yDNA PROJECT REPORT

Quarterly report from Tom Donahue (Member 5), the society's Group Administrator

Genealogy

The yDNA project is under a good head of steam with 39 members of whom 32 have returned their kits for analysis. Virtually all participants have signed on for the 25 marker test, which we recommend if the analysis of results is to be very useful. The results, presented, as in the past, in terms of the number of generations required with 50% probability to get to the most recent common male ancestor (tMRCMA) of two individuals are contained in the appended table.

Those who are clearly of Kerry O Donoghues of the Glen or of O Donoghue Mor (Ross) descent average 103 generations to their common male ancestor.

A continuing success story is that of John Michael O Donoghue (5). John is closest among us to Geoffrey Paul Vincent, The O Donoghue of the Glen. He has also matched at 25 sites with Gerard Gabriel O Donoghue of the UK (6). Previous detective work turned up John's Glenflesk/Killarney relatives. Now we think we understand how these O Donoghues of Gortdromakerrie and Barraduff are linked to Gerry's ancestors who moved to West Cork quite a while ago.

One of our members, Tighe (16) is an O Donoghue of Ross, and, because of their genetic proximity to him, we have assigned Rod (9) Mike (13) and John (15) to that sept as well. In my last report I related that Rod and Mike of Indianapolis matched at all 25 sites. Shortly afterward we learned that John O Donoghue of Carrick-on-Shannon did the same. So we have to find origins for three close cousins who had no prior knowledge of the existence of the others before our project came along. Fortunately, John's family has remained on the land in Coshe Mainge near Castlemaine and Abbeyfeale. Mike knows that his family has Coshe Mainge connections and Rod has hints in family lore that his ancestors also came from that part of Kerry. We have a promising family - that of John Donnoghue and Nora Leahy - who lived in the townland of Cools just on the Killarney-Killaha parish boundary south of the road to Barraduff and Mallow in the early 1800s, and this family may be the common link. These three participants have just had their 37 marker analysis carried out to refine somewhat our understanding of their relationship.

The Donohoes of Cavan who have been recruited for the project by the head of their society, Joseph Donohoe (10) of San Francisco, are an inhomogeneous group. Two (19) and (20) have tMRCA with Kerry O Donoghues not much greater than the 103 average among the latter. Perhaps, after all, there is something to the legend that O Donoghues who marched north with O Sullivan Beare after Kinsale, or would not return to Munster after the Boyne, remained in Cavan with Donohoes they found there. Joseph, himself, and James (11) of Ulster extraction are quite distant genetically from the rest of the project participants except Thomas R.(17) of Washington D C whose family is from Wexford and Joseph M. Donahue of Chillicothe, Ohio (18), a perfect 25 marker match with Thomas R.! The case of the Wexford family is perplexing. In tMRCMA they match up well with Joseph and James of Ulster which leaves us with the unlikely

possibility that their ancestors emigrated from Ulster to Leinster a long time ago.

Irish Septs

Before I examine our findings it may help if I give a brief description of the currently recognized tribal history in Ireland. The annals tell us that the Fir Bolg arrived in the country before the Milesians. The former, together with their contemporaries the Fir Domnann, the Laigin and the Ulaidh, are ethnologically classed as the Erainn. Tribes of this origin are prefixed generally with names like Corcu (perhaps meaning seed of) or ending in 'aighe' such as the Ciarraighe (black people) or Osraighe (deer people). The tribes of the second migration, the Milesian (the Gaels or Goidels), carry names like Eoghanachta (descendants of Eoghan) or Connachta (descendants of Conn). The annalists provided synthetic genealogies for our ancestors and so, in reality, ancestral tribal history is very confused.

Some of us in the project are interested in comparing our set of O Donoghues with members of other Irish and Scottish septs to test longstanding origin stories, such as the distinction, if real, between Milesians, the Eoghanachta and the O Neills (Connachta), and other Irish people - the Erainn or the Ulaidh, for example. In our last report I discussed our close relationship, genetically, with McCarthys who have their own project at Family Tree DNA. McCarthys average only 105 generations in tMRCMA from O Donoghues. This was not surprising in retrospect, although the indistinguishability of O Donoghues and McCarthys perhaps was. After all, our founding story has us descending from the Eoghanacht Eochu who came to West Cork from (presumably) Cashel about 65 generations ago. But this picture has been confused now by a comparison with the O Sheas who also have a thriving project. The O Sheas are Kerry Erainn, Corcu Duibne, who are supposed to be of Fir Bolg origin - at least not Milesian.

The O Sheas were dispossessed by McCarthy invaders of the Iveraght peninsula in the 12 th Century (some of them acquired a Milesian cover story later when they appeared in places like Tipperary). The O Sheas are on average only 92 generations in tMRCMA from the O Donoghues - and a fortiori - from the McCarthys.

These results have led me to explore our relationship to other septs and clans of Ireland and Scotland. The results are in tMRCMA McTiernan 97 and 180, O Moore 75 and 180, Kincaid 114, Kinney-McKinney 145, McCain 180 generations. McTiernans are from Cavan, Sligo and Connacht with links to O Rourke. There are clearly two lots, one much more distant from us than the rest. The same holds for the Moores. There are two sorts of Moores in Ireland and our survey exposes them. There are English settlers and the Leinster tribe of O Mordha, the greatest of the seven tribes of Leix. But the O Moores were supposed to be Laigin and not Milesian. yDNAwise they take their place alongside the Corcu Duibne O Sheas.

The Kincaids are an important clan from Stirlingshire in Scotland who are well established in Antrim, Derry and Sligo. The O Cathain were members of Cineal Eoghan who inhabited the Laigin district of Donegal before moving into Derry and Galway. The name is a common one in Coleraine and Antrim. There were also O Cains in Waterford. They afford us the chance to compare the Ur Milesian O Donoghues and O Neills and the result is not exactly a triumph for the sons of Mil. The McCains are about equally far from the Cavan Donohoes represented by Joseph and the Kerry O Donoghues - 200 and

180 generations, respectively. There are all sorts of Kinneys, a bunch of Scandinavians and a couple of other exotic types. If we look at the R1b haplotype (Western Europe - Atlantic modal) alone, we find the 145 generations result.

A preliminary conclusion is that there seem to be at least two strands of people in Ireland but that the distinction is not between the classical Milesian Goidels and "others" such as Erainn (the Laigin and the Ulaidh). More data and more study may bolster or modify this conclusion.
